On November 20, 2002, eight (8) bids were received for the replacement of boilers at DundalkMiddleSchool —Bid#RHA -340-03. This project consists of replacing the two existing boilers with three new boilers and all associated work. A summary of the bids received is attached. Based on the bids received, the Department of Physical Facilities recommends an award of contract to M&M Welding and Fabricators, Inc., the lowest responsive bidder, in the amount of \$274,400.00 for the Base Bid and Add Alternate #1. Add Alternate #1 includes all work associated with the removal and proper disposal of the mason rybase of each of the existing boilers.
