- now Honors/AP
- issues: (1) inappropriate degree of rigor for most 15 year olds; (2) kids afraid to take AP; (3) affects choice of rigor in other classes; (4) inhibits natural progression of rigor in social studies; (5) students taking on too much rigor; (6) what if pressure from former GT parents to increase rigor of honors; (7) lack of parent input before hand
- Where did this policy come from and why?

- came from BluePrint for Progress; focus on all students and access to all
- most APs for 11-12th graders
- support system put in place to support success of students
- AP advantage to students while GT not recognized by colleges

Response from Lyle Patzkowsky:

not true; offer to all students with differentiation within the classroom

Attendee Comments:

- several issues for high school, middle school
- GT not a reward → maximize experience
- GT loss not spoken about to parents
- shift all kids to GT curriculum
- What is bigger picture? Where is this coming from?
- Why no parental involvement?
- not developmentally appropriate for 14-15; for some the rigor of AP is too much; need appropriate study skills, work habits first

Response from Lyle Patzkowsky:

- research; other systems moved in this direction with success
- MD contract with ETS College Board has no role in this
- Towson High School (THS): two years ago THS combined classes (honors for all, no standard); common teacher planning time; staff development provided; instruction at highest quality possible/critical thinking skills; talked with THS students—bolstered their capabilities
- 25 kids to a class

can move into AP; advantages for going to college

- with increased instruction, standard students challenged to succeed, not create classroom problems
- couple years ago curriculum audit; outcomes need to align programs, increase rigor and work out of standard classes
