# POLICY ANALYSIS FOR BOARD OF EDUCATION POLICY 3209 <u>PURCHASING PRINCIPLES</u>

### **Statement of Issues or Questions Addressed**

In accordance with Board of Education Policy and Superintendent's Rule 8130, Policy 3209 is scheduled for review in school year 2011-2012. Policy 3209 outlines the Board's expectations for the procurement activities of the school system. Staff is recommending that the policy be revised to: (1) include a policy statement that clearly sets forth the principles of procuring services and goods in accordance with applicable laws and in accordance with the Ethics Code; (2) include an implementation section that empowers the Superintendent to establish purchasing procedures; and (3) conform with the Policy Review Committee's editing conventions.

## PURCHASING PRINCIPLES

#### I. POLICY STATEMENT

- THE BOARD OF EDUCATION OF BALTIMORE COUNTY (BOARD) A. ACKNOWLEDGES ITS RESPONSIBILITY [Each school within the Baltimore County Public Schools, as well as each Board member, employee, or volunteer, has a right and a responsibility to attempt] to secure high-quality instructional and support materials and services for students. [In doing so, those involved will be dealing with suppliers, manufacturers, contractors, and others doing business with the school system.] BOARD EXPECTS THAT SCHOOL SYSTEM FUNDS WILL BE EXPENDED AND HANDLED IN THE MOST EFFECTIVE. EFFICIENT, AND ETHICAL MANNER POSSIBLE, AND THAT PROCUREMENT ACTIVITIES WILL BE CARRIED OUT ACCORDANCE WITH APPLICABLE LAWS.
- B. The competitive nature of public purchasing and the efficient use of public funding require[s] that ethical standards be incorporated into all purchasing functions. Accordingly, ALL PURCHASING ACTIVITIES ON BEHALF OF THE BALTIMORE COUNTY PUBLIC SCHOOLS (BCPS) SHALL BE [all Board members, employees, and volunteers of the school system are] subject to the Board'S [of Education's] Ethics Code.

#### II. IMPLEMENTATION

THE BOARD DELEGATES TO THE SUPERINTENDENT THE AUTHORITY [It is the responsibility of the Office of Purchasing] to establish PURCHASING procedures THAT [to] ensure the ethical integrity of the procurement process.
