The Board, in partnership with CASE and TABCO, agrees to participate in a grant-funded program with Johns Hopkins University (JHU). The JHU grant-funded program will provide asynchronous and synchronous professional learning to forty (40) selected schools for the next four (4) years (FY25-FY28). Two (2) teachers and one (1) administrator from each of the forty (40) schools will be paid for attending and completing professional learning. The pay rate will be fifty dollars (\$50.00) per hour for both teachers and administrators. All funding will be provided through the JHU grant.
